- 1. Call to order: Don Stottlemire called the meeting to order at 9:00 am.
- 2. Approve Agenda: JR M moved to accept the agenda, Harold F seconded, motion passed.
- 3. Approve Minutes July 9, 2013: JR M moved to approve the minutes as submitted, Glen T seconded, motion passed.
- 4. Financial Report: Donna S presented the 2013 spending to date. JR M moved to accept the report and file for audit. Maurice B seconded, motion passed.
- 5. Coordinator Report: Donna S reported that she took our booth to fairs, prepared the HHW Annual Report, made the Solid Waste Plan revisions and submitted the revisions and county resolutions to KDHE, and made school visits for America Recycles Day.
